After several years of attempts to start a Knight Masons Council in Louisiana, permission was granted by the Grand Master of Louisiana, M W Jeff Webb, and members belonging to Great Chief's Council and to Tara Council organized Louisiana's first Knight Masons Council, Ray Wesley

Burgess Council #103, named for a Past Grand Master of Louisiana who dedicated himself to Masonic research and to expanding Masonic Light. On Saturday afternoon, January 16, eleven Louisiana Cousins, four Candidates, a visiting Virginia Cousin, a Past Great Chief and the

Great Chief gathered to institute, install and initiate the new Burgess Council. Great Chief, Dennis Zier, arrived from New York just before the meeting, and was assisted by Past Great Chief, Van Evans of Mississippi. The Great Chief opened the Grand Council and instituted Ray W. Burgess Council #103; then opened Ray W. Burgess Council and installed the new Officers and proceeded to initiate the new Cousins, including Grand Master Webb. Following the first meeting of the new Council where business was conducted, a meal was held at a local restaurant noted for its Cajun cuisine, and the food and fellowship were enjoyed by all. The Great Chief was returned to the airport and returned home later in the evening, and a great event closed with fifteen Louisiana Cousins enjoying the honor of being the newest Council in the Grand Council. Special thanks is given to Grand Scribe, Doug Jordan, for his patience, persistence and assistance in the endeavor. The membership includes Grand Lodge Officers, Grand Officers of all York Rite Bodies, the SGIG and Orient Officers of Scottish Rite, and Honorary Members Zier and Evans.

On February 23rd, shortly after being installed, Great Chef Edward P. Fagan, Jr. visited Washington Commandery No.1 in Est Hartford, Connecticut. He was formally received and welcomed as an Honorary Member of the Commandery. Washington Commandery is one of the oldest within the Grand Encampment of Knights Templar. It was instituted in Colchester Connecticut in 1796 but not chartered until 1801. It moved to East Hartford I 1819 and has been there ever since. 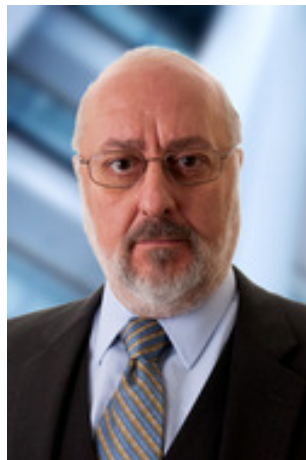

Sit Kt. Joseph S Crociata, a Life Member of St. Bridget’s Council 23 and Excellent Chief of Colmcille 77, was appointed to the office of Grand Sentinel. He was born in Rochester, NY, the son of a chef who was the son of a chef. He earned a BA degree from the State University of New York at Brockport and a Juris Doctor from Washington College of Law of the American University. Sir Kt. Corciata is a Founding Partner of Bonner Kiernan Trebach & Crociata LLP, and is one of the firm’s senior trial attorneys.



In Masonry, since being raised in 1981 in Craftsman (now Craftsman-Robertson) Lodge No. 969, Rochester, NY; he has affiliated with five other lodges, served as Master of two and Charter Secretary of a third. He is a member of the York Rite and Scottish Rite bodies in the Chicago

Annual Meeting Notes

Ex. James Shaw, acting for Ex. Robert Burleson opened the Annual Meeting of Great Chief's Council No. 0 in the Magnolia Room of the Hilton Alexandria Mark Center at 8:30 a.m. on February 12, 2010. Applications were accepted from nine candidates who were then obligated and instructed. The new members were welcomed by the Excellent Chief and Great Chief. The Council was then closed in ample form and The Grand Council resumed labor.

Because of the weather (2.5 feet of snow on the airport runway) several officers and many members were absent, but 128 members from 43 councils registered and business was completed.

In his Allocution Great Chief Zier noted: "One of the high points of my term was when my path took me to Pine Bluff, Arkansas on June 6th where I had the privilege of Instituting Harvey I. Mize Council No. 101. It was my first opportunity to exercise this power of the Great Chief, and I will cherish the warmth of the reception and impressive caliber of the nearly 40 Cousins who were Charter Members of this Council. My thanks to Royce H. Taylor who was installed as Excellent Chief for all the effort he put in to arranging the date.

Not only did we add a new Council to Knight Masonry in the U.S.A., but we added a new State, bringing the total under the Grand Council's jurisdiction to 39! Special thanks to M.E.P.G.C. Van Evans for assisting me in the Institution and for his tireless work to nail down all the necessary commitments and approvals to allow the Council to be created. I also want to thank John L. Belanger who I installed as Excellent Chief for his incredible hospitality and warmth and to compliment him on the caliber of the Charter Members of this fine new Council."

Following his report, Grand Treasurer Charles W. Wagner thanked the membership for electing him as Grand Treasurer for the past eight years and announced that he was retiring from the office.

The Grand Scribe reported that the members of one council had surrendered their charter after several years of inactivity. As of March 15, 95 of the remaining 100 councils had reported 7825 members—a gain of 203 from last year.
